

# Fee Schedule for 2024/25\*

## Designed for High School Students Studying Abroad

### PREMIUM CUSTODIANSHIP & HOMESTAY SERVICES

#### Custodianship Set-up & Homestay Placement (One-Time)

Custodian documentation is prepared to demonstrate that a named Custodian has been appointed to support an unaccompanied minor who intends to study in Canada. Homestay is based on each student's pre-determined needs. A Canadian host family is carefully screened for suitability and then assigned to a student. A host family profile is subsequently forwarded for review prior to a student's anticipated arrival.

#### Homestay Full Board Accommodation (5 months or 10 months)

Homestay accommodation includes three basic meals per day (breakfast, lunch and dinner); a private furnished bedroom; use of telephone (long distance charges not included); use of in-house laundry facilities; and access to high speed internet (video streaming not included). Students must supply own laptop and other accessories.

#### Specialty Meal Enhancement (5 months or 10 months)

Occasionally students require meals based on very specific dietary and/or medical needs. As the cost to prepare special diets is significantly higher, a monthly stipend is assessed. Unless medically necessary, specialty diets (ie high protein, vegan, gluten-free, halal, etc.) cannot be requested after the program has already begun.

#### Mandatory Custodial Monitoring (5 months or 10 months)

Unaccompanied minor-aged students studying in Canada must have a named Custodian who ensures the student is receiving ongoing care and support. All students are assigned an FCI Custodian Representative while they reside in Canada. This person is available to assist with urgent and emerging issues and provide guidance during unanticipated emergencies when the assigned host is unavailable.

† Students are expected to arrive no earlier than the weekend prior to the school program start date and depart no later than the weekend immediately following the school program end date. Earlier arrivals or later departures are subject to the nightly rate.

‡ Currently international travelers who test positive on the day of arrival in Canada, on the Day-8 molecular test after arrival, or on the day of departure from Canada must report to the Public Health Agency of Canada within 24-hours and isolate immediately. The fee covers additional housing costs associated with an isolated stay in the homestay residence.
