

Fee Schedule for General Applicants*

Services Designed for International University/College Students in British Columbia

Homestay Accommodation Services

Basic homestay accommodation includes a private bedroom with closet and student desk; the use of telephone (long distance charges not included); and the use of in-house laundry facilities. Students will have access to limited highspeed internet but must supply their own laptops and accessories.

- **Homestay Placement Fee (One-time)** **\$450⁰⁰ CDN**
Based on an individual's pre-determined needs, Canadian host families are carefully interviewed and screened for suitability. If, within the first month, a student is not satisfied with their assigned host family a second placement can be arranged at no additional charge.
- **Homestay Accommodation Fee**
 - **Full Board Option (Monthly)** **\$1050⁰⁰ CDN**
Private furnished bedroom and three meals (breakfast, lunch and dinner) daily.
 - **Half Board Option (Monthly)** **\$925⁰⁰ CDN**
Private furnished bedroom and two meals (breakfast and dinner) daily.
 - **Specialty Meal Plan Enhancement Option (Monthly)** **\$400⁰⁰ CDN**
Gluten-free, lactose-free, vegan, athletic/high-calorie diets or medically required supplements.
 - **Private Bathroom Enhancement Option (Monthly)** **\$100⁰⁰ CDN**
Exclusive use of an assigned bathroom equipped with either a shower or bathtub.
 - **Nightly Rate for Less than Two Weeks (Nightly)** **\$45⁰⁰ CDN**
Short-term nightly accommodation for less than one (1) week or during peak periods.
- **Homestay Re-placement Fee (Per Occurrence)** **\$350⁰⁰ CDN**
Students requesting a homestay change after the first month are assessed a re-placement fee.

Monitored Custodial Guardianship Services

Students under the age of 19 years in British Columbia are generally required to have an assigned "Custodial" who oversees the student's care until the student reaches the age of majority. FCI's Monitored Custodial Guardianship service is for minor-aged university or college students either residing on-campus or in an approved homestay.

- **Custodial Guardianship Set-up Fee (One-time)** **\$350⁰⁰ CDN**
Preparation of notarized documentation for visa purposes and a formal agreement outlining the terms and conditions that exist between the student, the natural parents and FCI staff.
- **Mandatory Custodial Monitoring (Per 4-Month Term to the Age of Majority)** **\$300⁰⁰ CDN**
Our capable staff regularly liaise between the student, the school, the assigned host family (if applicable) to ensure that the student is receiving adequate care and support while in Canada.

Airport Transportation Services

- **Airport Pick-up (One-way)** **\$125⁰⁰ CDN**
Door to door chauffeured transportation from point of entry to the student's assigned residence by courteous drivers who are professionally licensed and insured.

Wire Transfer Fee / Monthly Payment Processing Fee (Per Occurrence) **\$50⁰⁰CDN**

* The term "General Applicant" refers to all applicants for homestay and/or custodial guardianship services except high school students. Prices are in effect for applications received from November 1, 2021 to October 31, 2022 but are subject to change prior to enrollment due to increasing food costs. Check before you apply.
